Review of Chapter 22 triennial compliance and annual update filings

- ▶ On or about April 1 each year – utilities file either triennial compliance filing or annual update filing per 22.080(1)
- ▶ Staff, OPC other parties file comments within 150 days for triennial compliance filings and within 30 days for annual updates
 - Alleged deficiencies – rule or statute violation
 - Alleged concerns – not rule or statute violation
 - Suggested remedy for each alleged deficiency or concern
- ▶ Joint filing by utility, Staff, OPC and any party filing comments is filed within 60 days of filed comments to resolve alleged deficiencies and concerns or to determine which deficiencies and concerns cannot be resolved per 22.080(9)



Chapter 22

Electric Utility Resource Planning

- ▶ First effective in 1993 and revised in 2011
- ▶ Authority: 386.040, .250, and .610; and 393.140
- ▶ 23 pages in CSR and nine separate rules:
 - .010 Policy Objectives
 - .020 Definitions
 - .030 Load Analysis and Load Forecasting
 - .040 Supply-Side Resource Analysis
 - .045 Transmission and Distribution Analysis
 - .050 Demand-Side Resource Analysis
 - .060 Integrated Resource Plan and Risk Analysis
 - .070 Resource Acquisition Strategy Selection
 - .080 Filing Schedule, Filing Requirements, and Stakeholder Process



22.080(16) The commission will issue an order which contains its findings regarding at least one (1) of the following options:

- ▶ (A) That the electric utility's filing pursuant to this rule either does or does not demonstrate compliance with the requirements of this chapter, and that the utility's resource acquisition strategy either does or does not meet the requirements stated in 20 CSR 4240-22.
- ▶ (B) That the commission approves or disapproves the joint filing on the remedies to the plan deficiencies or concerns developed pursuant to section (9) of this rule;
- ▶ (C) That the commission understands that full agreement on remedying deficiencies or concerns is not reached and pursuant to section (10) of this rule, the commission will issue an order which indicates on what items, if any, a hearing(s) will be held and which establishes a procedural schedule; and
- ▶ (D) That the commission establishes a procedural schedule for filings and a hearing(s), if necessary, to remedy deficiencies or concerns as specified by the commission.



Acknowledgement

- ▶ 22.080(17) If the commission finds that the filing achieves substantial compliance with the requirements outlined in section (16):
 - The commission may acknowledge the utility's preferred resource plan or resource acquisition strategy as reasonable at a specific date.
 - The commission may acknowledge the preferred resource plan or resource acquisition strategy in whole, in part, with exceptions, or not at all.
 - Acknowledgements shall not be construed to mean or constitute a finding as to the prudence, pre-approval, or prior commission authorization of any specific project or group of projects.
