Senate Bill 4: Relating to Utilities

- Omnibus Utilities Bill
- Contains 26 provisions relating to utilities
- Passed by the Missouri Senate on February 24, 2025
- Passed by the Missouri House on March 13, 2025
- Signed by the Governor on April 9, 2025
- Provisions effective August 28, 2025 unless otherwise specified
