

How to View PSC Case Files

The Electronic Filing & Information System (EFIS) is the Missouri Public Service Commission's e-filing and document management system for Commission cases, complaints, inquiries, public comments, Commission agendas, tariffs, compliance filings, and more.

Steps to Access PSC Case Files

1. Go to: www.psc.mo.gov
2. Click on the heading **"How Do I... Access EFIS"**
3. Under the heading **"How To Look Up Information On A Specific Case"** proceed to **"View Information on a Specific Case"** and select **"Existing Case e-Filing & Search"**.

Docket Sheet

To view a docket sheet for Commission cases, click the "Existing Case e-Filing & Search" and input the Commission's case number in the "Case No." field, then press the "enter" key or click the "Search" button.

About EFIS

Every case has a docket number assigned to it (Case & Utility Designator Reference Guide). The first letter identifies the type of utility (i.e., E for electric, G for gas, W for water, S for sewer); the second letter identifies the type of case (i.e., A for application, M for merger, R for Rate, C for complaint); the first set of numbers refers to the fiscal year in which the case was filed; and the second set of numbers indicates the sequential case number of each filing. To view a specific filing you are interested in, click on the item number (i.e., No. 24) which is on the left side of the date filed column.
