



To search for agenda minutes in EFIS:

NOTE: Users do not need a user account to search for agenda minutes in EFIS.

- 1) Navigate to EFIS.
- 2) Select the 'Agenda & Public Meetings' tab.



- 3) Select the 'Agenda Search' link.



- 4) To view the newest agenda minutes, click the **View Newest Minutes** button under Agenda Search at the top of the page.
- 5) To view any agenda minutes, input the applicable search criteria.
- 6) Click the **Search** button; or click the **Clear** button to clear all fields and start over.

- 8) Click the agenda tracking number under the **Agenda No.** field to view the agenda and/or minutes.
