- Everything in this presentation is for informational use only.
- This example may not address each line individually within the Annual Report.
  - Depending on the specific needs of your company, the lines not addressed may need to be completed.
  - Additional data may be required that is not shown in this example.
- Ensure your Company name and year of the report is on the top of each page.
  - If using the Excel version of the form, and these sections have been correctly completed, this information will auto-populate from the Cover Page onto each page.
- If using the PDF version of the Annual Report, all lines on each page of the report will need to be completed manually.

# Important To Remember

When completing your report:

- Ensure your name and calendar year appear on each page.
- Make sure all information is accurate on each page.
- All yellow boxes within the Excel Version contain formulas. You **will not** be able to enter information into those areas.
- After completing the entire report, ensure pages 4 and 5 balance.
  - If these values do not match, line 21 column “b” on both pages, the cell will turn red indicating an error.
- Ensure all columns requiring a label are labeled.
- If there are metered customers on the system, be sure to include the gallons sold.
- Each line on the Verification page **must** be filled in completely, including all signatures.

  - (6) A(n) \_\_\_\_\_ utility that is unable to meet the submission date established in section (1) of this rule may obtain an extension of up to thirty (30) days for submitting its annual report by:
    - (A) Submitting a written request, which states the reason for the extension, to the attention of the Secretary of the Commission prior to April 15; and
    - (B) Certifying that a copy of the written request was sent to all parties of record in pending cases before the Commission where the utility's activities are the primary focus of the proceedings.

- **To request a 30-day extension, companies may either submit:**

- 1. A completed Annual Report Extension Request – Fillable Form on the PSC Website (<http://psc.mo.gov/forms/forms>) including (electronic) signature,

- **OR**

- 2. A letter including a) the reason for the request, and b) naming all pending cases before the Commission with a statement certifying that the Company has sent copies of this request to all parties in these cases. The letter should have contact information and be signed by the requestor.

- **Over 30-day Extension Requests**

- This is a formal request (in pleading form) that must be submitted no later than April 15 and submitted in a case requesting an extension date past May 15<sup>th</sup>.

  - (7) A(n) \_\_\_\_\_ utility that is unable to meet the submission date established in section (1) of this rule may request an extension of greater than thirty (30) days for submitting its annual report by:
    - (A) Filing a pleading, in compliance with the requirements of Chapter 2 of 4 CSR 240, which states the reason for and the length of the extension being requested, with the Commission prior to April 15; and
    - (B) Certifying that a copy of the pleading was sent to all parties of record in pending cases before the Commission where the Utility's activities are the primary focus of the proceedings.
