NOTICE OF EXTENDED EFFECTIVE DATE FOR TARIFF

Issue Date: January 4, 2018

Environmental Utilities, LLC ("Company") filed a letter ("extension")¹ asking the Commission to:

Please extend the effective date of the [pending] tariff from January 5, 2018 to January 20, 2018 to comply with 4 CSR 240-3.050.

The cited regulation requires the pending tariffs to bear an effective date that is not less than 45 days after the filing of the pending tariffs.² The extension brings the pending tariffs into compliance with that requirement. The extension is effective on filing.³ Therefore, the proposed effective date of the pending tariffs is now January 20, 2018.
