ORDER SETTING LOCAL PUBLIC HEARINGS AND DIRECTING NOTICE

On July 1, 2016, Union Electric Company, d/b/a Ameren Missouri, submitted proposed tariff sheets designed to implement a general rate increase for retail electric service. In a July 12 order, the Commission directed the parties to file recommendations regarding the times, dates, and locations for local public hearings. Ameren Missouri, Public Counsel, and Staff responded on August 11, offering suggested times and locations for such hearings. The Commission will generally adopt the local public hearing schedule proposed by the parties, although some proposed hearing locations have changed to reflect facility availability.

The Commission will direct Ameren Missouri to provide notice of the hearings to its customers using the agreed-upon notice language described by Staff in its pleading of August 25.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Public Information Office shall make an informational presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing.
- 2. Union Electric Company, d/b/a Ameren Missouri, the Commission's Staff, and the Office of the Public Counsel shall each prepare a one-page statement outlining their current assessment of the case, and shall bring sufficient copies for distribution at the question-and-answer session that begins each local public hearing.
- 3. Union Electric Company, d/b/a Ameren Missouri, the Commission's Staff, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session.
- 4. Any other party, at its discretion, may prepare a statement and make a representative available to address substantive issues during the question and answer session.

IMPORTANT NOTICE

Ameren Missouri has filed tariff sheets with the Missouri Public Service Commission (PSC) that would increase the company's electric service revenues by approximately \$206 million. In its filing before the PSC, Ameren Missouri has stated that the main drivers of this rate increase request include new investment in Ameren Missouri's system, higher regional transmission operator charges, reduced revenues from Ameren Missouri's largest customer and reduced revenues due to reduced demand on Ameren Missouri's system. The overall request would raise a typical residential customer's bill by approximately 7.77 percent, translating to just more than an approximately \$8.27 monthly increase. The permanent rate increase request, which is subject to regulatory approval, would take effect no later than May 28, 2017. Ameren Missouri's rate filing also includes a request to continue its fuel adjustment clause in substantially its current form, which would, based on the customer's usage, continue to allow 95 percent of increases or decreases in net energy costs to be passed through to customers as a separate line item on customers' bills.

22. Union Electric Company, d/b/a Ameren Missouri, shall place advertisements in the newspapers serving its service territory. The advertisements shall contain the information from the customer notice relevant to the customers in the newspaper's circulation area.
